- (2) Refrain from behaving or acting in any manner that may cause injury or contribute to injuring himself or other people while occupying an amusement ride.

Failure to comply is a misdemeanor.

Furthermore, I hereby release the company and authorize the use of photographs and video footage of my child or children for advertising, publicity, website, or other business purpose and release all claims of any kind of account for such use.
